

RESOLUTION NO. 2024-R-243

AUTHORIZING THE CITY MANAGER TO ACCEPT ADDITIONAL FUNDS IN THE AMOUNT OF \$1,598,165.00 FROM THE COMMISSION ON STATE EMERGENCY COMMUNICATIONS TO FUND THE NG911 PROGRAM IN THE AMOUNT OF \$98,165.00 AND EQUIPMENT BUDGET IN THE AMOUNT OF \$1,500,000.00 ON FY 2024 FOR THE SOUTH TEXAS REGION, INCLUDING JIM HOGG, STARR, WEBB, AND ZAPATA COUNTIES, TO MAKE A TOTAL ON THE BIENNIUM OF 7,195,515.00 FOR THE PERIOD BEGINNING SEPTEMBER 1, 2023 THROUGH AUGUST 31, 2025.

WHEREAS, on September 19, 2022 City Council adopted the 9-1-1 Regional Administration fiscal year 2022-2023 annual budget (RCOM24); and

WHEREAS, on September 18, 2023, City Council adopted the 9-1-1 Regional Administration fiscal year 2023-2024 annual budget (RCOM25); and

WHEREAS, the City of Laredo on September 18, 2023 accepted a grant from the Commission on State Emergency Communications (CSEC) to fund the 9-1-1 Program and Equipment budgets for the South Texas Region for Fiscal Years 2024-2025; and

WHEREAS, the City of Laredo will accept an additional funds to grant from the Commission on State Emergency Communications (CSEC) to fund the Equipment budgets for the South Texas Region for Fiscal Year 2024; and

WHEREAS, on July 26, 2023, the Commission on State Emergency Communications approved the FY 2024 and FY 2025 Strategic Plan for South Texas 9-1-1 Region, as administered by the City of Laredo; and

WHEREAS, the Strategic Plan authorizes expenses for all administrative, program, and capital budgets for South Texas Region, including Jim Hogg, Starr, Webb and Zapata Counties; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

Section 1:

The City of Laredo 9-1-1 Regional Administration will accept a grant from the Commission on State Emergency Communications to fund 9-1-1 program and equipment budgets in order to administer the 9-1-1 Service Program in the South Texas Region.
