AUTHORIZING THE CITY MANAGER TO RATIFY THE ACCEPTANCE OF A GRANT IN THE AMOUNT OF \$58,451.25 FROM THE OFFICE OF THE GOVERNOR, CRIMINAL JUSTICE DIVISION, FOR THE FUNDING OF THE FY2026 BODY-WORN CAMERA GRANT PROGRAM. THE GRANT PERFORMANCE PERIOD IS FROM OCTOBER 01, 2025 THROUGH SEPTEMBER 30, 2026. THIS GRANT PROGRAM IS TO AID MUNICIPAL POLICE DEPARTMENTS IN ESTABLISHING OR ENHANCING BODY-WORN CAMERA (BWC) PROGRAMS. THE CITY OF LAREDO WILL BE RESPONSIBLE FOR THE REQUIRED MATCH OF \$19,483.75, FROM GENERAL FUND, FOR A TOTAL PROJECT AMOUNT OF \$77,935.00. FUNDING IS AVAILABLE FOR IN THE SPECIAL POLICE FUND.

Whereas, the City of Laredo finds it in the best interest of the citizens of Laredo, that the FY2026 Body-Worn Camera (BWC) Program be operated for the 2025-2026 fiscal year; and

Whereas, the City of Laredo designates the City Manager as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter or terminate this grant on behalf of the City of Laredo; and

Whereas, the City of Laredo has agreed that in the event of loss or misuse of the Office of the Governor funds, the City of Laredo assures that the funds will be returned to the Office of the Governor in full.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

Section 1: Authorizing the City Manager to ratify the acceptance of a grant in the amount of \$58,451.25 from the Office of the Governor, Criminal Justice Division, for the funding of the FY2026 Body-Worn Camera Grant Program. The grant program is to aid municipal police departments in establishing or enhancing body-worn camera (BWC) programs. The City of Laredo will be responsible for the required match of \$19,483.75, from General Fund, for a total project amount of \$77,935.00. Funding Is available in the Special Police Fund.

Section 2: It authorizes the City Manager to execute all necessary forms and documents to obtain said grant and to effectuate its terms.
