A RESOLUTION OF THE CITY COUNCIL OF THE CITY TEXAS, LAREDO. **AUTHORIZING** MANAGER TO SUBMIT AN APPLICATION TO THE CANCER PREVENTION & RESEARCH INSTITUTE OF TEXAS (CPRIT) FOR THE CANCER SCREENING AND EARLY DETECTION GRANT, IN THE ESTIMATED TOTAL AMOUNT OF \$1,500,000.00, WITH NO MATCH THE CITY OF LAREDO PUBLIC HEALTH DEPARTMENT **FOR** THE TERM PERIOD FROM SEPTEMBER 01, 2025 THROUGH AUGUST 31, 2026, WITH UP TO TWO (2) ONE YEAR EXTENSIONS, FOR A TOTAL ESTIMATED AMOUNT OF \$4,500,000.00; AND FURTHER AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RESULTING FROM THE AWARD OF THIS GRANT. ANY FUNDING AS A RESULT OF THIS APPLICATION WILL BE APPROPRIATED IN THE LAREDO PUBLIC HEALTH DEPARTMENT FUND CANCER SCREENING AND EARLY DETECTION GRANT.

WHEREAS, the City of Laredo Public Health Department wishes to apply for this funding opportunity by the Cancer Prevention & Research Institute of Texas (CPRIT) through the Cancer Screening and Early Detection Grant. Through this award, the City of Laredo Public Health Department will be able to provide evidence-based cancer screening and early detection services for medically underserved populations in Laredo and Webb County and enhance access to cancer screenings, improve patient navigation, and strengthen local healthcare infrastructure.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

The City Manager is hereby authorized to submit an application to the Cancer Prevention & Research Institute of Texas (CPRIT) for the Cancer Screening and Early Detection Grant, in the estimated total amount of \$1,500,000.00, with no match for the City of Laredo Public Health Department for the term period from September 01, 2025 through August 31, 2026, with up to two (2) one year extensions, for a total estimated amount of \$4,500,000.00; and further authorizing the City Manager to execute all documents resulting from the award of this grant. Any funding as a result of this application will be appropriated in the Laredo Public Health Department Fund – Cancer Screening and Early Detection Grant.
