A RESOLUTION OF THE CITY COUNCIL OF LAREDO, TEXAS, AUTHORIZING A FEE WAIVER FOR THE PIT KINGS EVENT TO BE HELD AT THE UNI-TRADE STADIUM ON NOVEMBER 14–15, 2025, AND PROVIDING A FEE WAIVER IN AN AMOUNT UP TO \$8,000.00 THROUGH COMMUNITY SUPPORT AND SPONSORSHIP FUNDS FROM PARTICIPATING COUNCIL DISTRICTS APPROVED THROUGH MOTION AT THE OCTOBER 6, 2025 COUNCIL MEETING, SUBJECT TO THE AVAILABILITY AND ALLOCATION OF FUNDS BY PARTICIPATING DISTRICTS, AND AUTHORIZING THE CITY MANAGER TO IDENTIFY OTHER APPROPRIATE FUNDING SOURCES, IF REQUIRED AND SUBJECT TO COUNCIL APPROVAL

WHEREAS, the City of Laredo seeks to encourage community events that promote civic engagement, recreation, and local economic activity; and

WHEREAS, the Pit Kings event, scheduled for November 14–15, 2025, at the City-owned Uni-Trade System Arena, is anticipated to attract attendees from Laredo and surrounding areas, enhancing community participation and local economic impact; and

WHEREAS, the City Council, at its meeting of October 6, 2025, approved the allocation of Community Support and Sponsorship Funds from Council Districts to cover applicable costs associated with the Pit Kings event; and

WHEREAS, the City Council intends for this fee waiver to be supported primarily through Community Support and Sponsorship Funds from those Council Districts whose representatives have agreed to allocate such funds, and recognizes the importance of maximizing district participation to demonstrate community investment; and

WHEREAS, should the full amount not be reached solely through participating Council District allocations, the City Council authorizes the City Manager to identify other appropriate funding sources, if required and subject to Council approval, to ensure the successful implementation of this Resolution;

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF LAREDO, TEXAS, THAT:

The City Council hereby authorizes a fee waiver in an amount up to \$8,000 for the Pit Kings event to be held at the Uni-Trade System Arena on November 14–15, 2025.

The intended and primary funding source for this waiver shall be Community Support and Sponsorship Funds from participating Council Districts.

If required, and subject to Council approval, the City Manager, or his designee, may identify other appropriate and available funding sources to supplement district allocations in order to ensure successful implementation of this Resolution.

The City Manager, or his designee, is authorized to take all necessary steps to implement this Resolution.
