

RESOLUTION NO. 2025-R-232

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS, AUTHORIZING THE ACCEPTANCE OF A REIMBURSABLE GRANT AGREEMENT WITH A PROJECT ID OF M2622LRED FROM THE TEXAS DEPARTMENT OF TRANSPORTATION IN THE AMOUNT OF \$100,000.00 FOR THE ROUTINE AIRPORT MAINTENANCE PROGRAM (RAMP) FOR FISCAL YEAR 2026. LOCAL MATCH IS \$11,111.11 FOR A TOTAL PROJECT COST OF \$111,111.11. AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS. FUNDING WAS APPROPRIATED AND AVAILABLE IN THE LAREDO INTERNATIONAL AIRPORT CONSTRUCTION FUND.

WHEREAS, the Texas Department of Transportation (TxDOT), pursuant to Chapter 21 and Chapter 22 of the Texas Transportation Code, is authorized to assist in the development and maintenance of airports in the State of Texas; and

WHEREAS, TxDOT has offered the City of Laredo, Texas, as Sponsor of Laredo International Airport, financial assistance under the Routine Airport Maintenance Program (RAMP), TxDOT Project ID: M2622LRED, for eligible airport maintenance activities; and

WHEREAS, the grant provides for reimbursement of ninety percent (90%) of eligible project costs, not to exceed \$100,000.00, with the City of Laredo responsible for the remaining ten percent (10%); and

WHEREAS, the City Council finds it in the best interest of the City of Laredo and its citizens to accept said grant in order to support the continued operation, maintenance, and safety of Laredo International Airport;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS THAT:

1. The City of Laredo hereby accepts the Reimbursable Grant Agreement from the Texas Department of Transportation under the Routine Airport Maintenance Program for Fiscal Year 2026, Project ID: M2622LRED, in an amount not to exceed \$100,000.00.
2. The City Manager, or designee, is authorized to execute the grant agreement, designations, certifications, and all other necessary documents in connection with the grant, and to expend funds as required to meet the City's ten percent (10%) local share.
3. The City further agrees to comply with all terms, conditions, covenants, and responsibilities as set forth in the RAMP Reimbursable Grant Agreement.
4. This resolution shall take effect immediately upon its passage.
