

ORDINANCE NO. 2024-O-XXX

AUTHORIZING THE CITY MANAGER TO AMEND THE BUDGET AND APPROPRIATE \$50,000.00 TO THE FY23-24 LAREDO INTERNATIONAL AIRPORT BUDGET FOR FUNDING THE FY 2024 ROUTINE AIRPORT MAINTENANCE PROGRAM (RAMP) GRANT. FUNDS ARE BEING AWARDED BY THE TEXAS DEPARTMENT OF TRANSPORTATION (TXDOT). THIS FUNDING WILL BE USED FOR AIRPORT MAINTENANCE AT THE LAREDO INTERNATIONAL AIRPORT. LOCAL MATCH OF \$11,111.11 WAS APPROPRIATED IN THE FY23-24 LAREDO INTERNATIONAL AIRPORT BUDGET.

WHEREAS, the Laredo International Airport has received a grant award from the Texas Department of Transportation (TxDOT) for the purpose of funding the FY 2024 Routine Airport Maintenance Program (RAMP) Grant.

WHEREAS, the FY 2023-2024 budget shall be amended to appropriate revenues and expenditures in the amount of \$50,000.00; and

WHEREAS, the Laredo International Airport will use said grant for purposes of funding expenses used for general maintenance on airside and landside improvements; and

WHEREAS, the Laredo International Airport has agreed that in the event of a loss or misuse of funds, the Laredo International Airport assures that the funds will be returned to the the Texas Department of Transportation (TxDOT).

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

SECTION 1. Accept the award of a grant from the Texas Department of Transportation (TxDOT) for the purpose of funding the FY 2024 Routine Airport Maintenance Program (RAMP) Grant and amending the FY 2024 budget by appropriating revenues and expenditures in the amount of \$50,000. This funding shall be utilized for expenses used on general maintenance for airside and landside improvements at the Laredo International Airport. Local Match of \$11,111.11 was appropriated in the FY23-24 Laredo International Budget.

SECTION 2. This ordinance shall be cumulative of all provisions of ordinances of the City of Laredo, except where provisions of this ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

SECTION 3. It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this ordinance are severable, and if any phrase, clause, sentence, paragraph, or section of this ordinances, shall be declared unconstitutional by the valid judgment or decree or any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

SECTION 4. This Ordinance shall become effective upon passage thereof.
