AUTHORIZING THE CITY MANAGER TO SUMBIT A CONTINUATION APPLICATION TO THE TEXAS DEPARTMENT OF STATE HEALTH SERVICES THROUGH THE SOUTH TEXAS DEVELOPMENT COUNCIL (STDC), HIV RYAN WHITE GRANT IN THE AMOUNT OF \$173,573.00 WITH NO MATCH FOR THE CITY OF LAREDO PUBLIC HEALTH DEPARTMENT FOR THE TERM PERIOD FROM APRIL 01, 2024 THROUGH AUGUST 31, 2024, AND FURTHER AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RESULTING FROM THE AWARD OF THIS GRANT. ANY FUNDING AS A RESULT OF THIS APPLICATION WILL BE APPROPRIATED TO THE HIV RYAN WHITE GRANT - PUBLIC HEALTH DEPARTMENT FUND.

WHEREAS, City of Laredo Public Health Department wishes to apply for the funding opportunity by the Texas Department of State Health Services, South Texas Development Council (STDC) to be considered for funding through the HIV Ryan White Grant; and,

WHEREAS, through this award, Laredo Public Health Department continues to provide public health services through programs that provide case management, medical, nursing, dental care, insurance assistance, diagnostic, monitoring, medical follow-up services, personal care services, day treatment or other partial in-patient services, home intravenous and aerosolized drug therapy, routine diagnostic testing, hospice care, and other essential social support services.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

Section 1: The City Manager is hereby authorized to submit a continuation application to the Texas Department of State Health Services through the South Texas Development Council (STDC), HIV Ryan White Grant in the amount of \$173,573.00, with no match for the City of Laredo Public Health Department for the term period from April 01, 2024 through August 31, 2024, and further authorizing the City Manager to execute all documents resulting from the award of this grant. Any funding as a result of this application will be appropriated to the HIV Ryan White Grant - Public Health Department fund.
