FIELD NOTES DESCRIBING A 35.3737 ACRE PARCEL, MORE OR LESS, BEING OUT OF A 286.17 ACRE TRACT, RECORDED IN VOLUME 5351, PAGES 186-201, OFFICIAL PUBLIC RECORDS OF WEBB COUNTY, TEXAS. HEREIN DESCRIBED PARCEL SITUATED IN PORCION 35, ABSTRACT 546, ORIGINAL GRANTEE JOSE M. DIAS AND SURVEY 2149, ABSTRACT 594, ORIGINAL GRANTEE R.H. RAINS, WEBB COUNTY, TEXAS. BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

Commencing at a found ½ inch iron rod, being the northwesterly corner of Lot 1 of Block 1, Walmart – Laredo, recorded in Volume 25, Page 120, Plat Records Webb County, Texas, situated on the easterly right-of-way line of Zapata Highway;

Thence, N64°40'29"E, a distance of 336.30 feet, to a set ½ inch iron rod, for the **POINT OF BEGINNING** of this 35.3737 Acre Parcel and the **southwesterly corner** hereof;

Thence, N1°47'20"E, with the westerly line of herein described parcel, a distance of 2,398.42 feet, to a set ½ inch iron rod, for the **northwesterly corner** hereof;

Thence, N89°26'36"E, with the northerly line of herein described parcel, a distance of 281.30 feet, to a set ½ inch iron rod, for the **most northerly northeast corner** hereof;

Thence, S1°38'06"W, with the northerly line of herein described parcel, a distance of 101.83 feet, to a set ½ inch iron rod, for an interior corner hereof;

Thence, S88°12'40"E, with the northerly line of herein described parcel, a distance of 75.90 feet, to a set ½ inch iron rod, for a point of curvature hereof;

Thence, along a curve to the right, with a chord bearing S77°47'01"E, 304.07 feet, subtended by an arc having a radius of 840.00 feet, with the northerly line of herein described parcel, a distance of 305.75 feet, to a set ½ inch iron rod, for the **most easterly northeast corner** hereof:

Thence, S1°47'20"W, with the easterly line of herein described parcel, a distance of 1,580.48 feet, for a point of deflection hereof;

Thence, S3°51'58"E, with the easterly line of herein described parcel, a distance of 466.21 feet, for a point of deflection hereof;

Thence, S1°02'20"W, with the easterly line of herein described parcel, a distance of 163.20 feet, to a set ½ inch iron rod, for the **southeasterly corner** hereof;

Thence, S88°05'45"W, with the southerly line of herein described parcel, a distance of 705.82 feet, to said **POINT OF BEGINNING**, containing within these metes and bounds 35.3737 Acres, more or less
