- 2) Bone's Custom Cycles, Laredo, Texas in an amount up to \$220,000.00;

The term of this contract shall be for a period of one (1) year beginning as of the date of its execution and is contingent upon the availability of appropriated funds. This contract can be renewed three additional one year extension periods upon mutual agreement of the parties. Funding is available in the Fleet Department Fund.

### BACKGROUND

The City received two bids through Cit-E-Bid for awarding a contract for lawn maintenance equipment repairs. This contract establishes an hourly labor rate for repair services and percentage discount for parts needed for the City's lawn maintenance equipment. All repairs shall be done at the local vendors shop.

The term of this contract shall be for a period of one (1) year beginning as of the date of its execution. The contract allows for one (1) additional one year extension upon mutual agreement of the parties. Should the vendor desire to extend the contract for the additional one-year period, it must so notify the City in writing no later than sixty (60) days before the expiration of the prior term. Such notification shall be effective upon actual receipt by the City. Renewals shall be in writing and signed by the City's Purchasing Manager & City Manager or his designee, without further action by the Laredo City Council, subject to and contingent upon appropriation of funding therefore. All annual contracts shall bound by the terms of the bid documents. The City shall also

have the right to extend this contract under the same terms and conditions beyond the original term or any renewal thereof, on a month to month basis, not to exceed 3 months. Said month to month extensions shall be in writing, signed by the City's Purchasing Manager & City Manager or his designee, and shall not require City Council approval, subject to and contingent upon appropriation of funding therefore. The City reserves the right to renew or rebid this contract, if the appropriated funds initially approved by City Council are exhausted before the contract expiration date. This contract shall be the responsibility of and administered by the vendor and the City of Laredo Fleet Department.





### 8.0 BIDDER DISCOUNTS

### 10.0 AWARD OF CONTRACT
