

**RESOLUTION NO. 2025-R-126**

**RESOLUTION AUTHORIZING THE CITY MANAGER TO SUBMIT AN APPLICATION IN THE AMOUNT OF \$1,250,000.00 TO THE LAREDO & WEBB COUNTY AREA METROPOLITAN PLANNING ORGANIZATION (LWCAMPO), FOR THE 2025 TRANSPORTATION ALTERNATIVES (TA) SET-ASIDE PROGRAM TO FUND THE DESIGN, ENGINEERING, TESTING, AND CONSTRUCTION OF INDEPENDENCE HILLS PARK – SUMMERS TRAILS. THE PROJECT WILL PROVIDE, PROMOTE AND SUPPORT MOBILITY ENHANCEMENT, CONNECTIVITY, ACCESSIBILITY AND COMMUNITY SAFETY GOALS. THIS NOTICE OF FUNDING OPPORTUNITY IS ON A REIMBURSEMENT BASIS. GRANT MATCH OF 20% IN THE AMOUNT OF \$250,000.00 IS AVAILABLE IN DISTRICT 1 PRIORITY FUNDS AND 2015 CERTIFICATE OF OBLIGATION AND ENVIRONMENTAL 2019 CERTIFICATE OF OBLIGATION.**

**WHEREAS**, the Laredo & Webb County Area Metropolitan Organization (LWCAMPO) has announced, and made available reimbursable funds for a *Transportation Alternatives (TA) Set-Aside* for the 2026-2028 fiscal year; and,

**WHEREAS**, the *City Council of the City of Laredo* acknowledges and expresses its sincere and cordial intention to apply for the aforementioned funding opportunity whose implementation date cannot begin until funding is approved; and,

**WHEREAS**, the *City Council of the City of Laredo* finds it in the best interest of the citizens of the City of Laredo, Texas to formally apply and submit an application for the aforementioned *Laredo & Webb County Area Metropolitan Planning Organization* application thorough the *City of Laredo's Economic Development Department* in order to provide promote and support mobility enhancement, connectivity, accessibility and community safety goals, as well as the Laredo & Webb County Area Metropolitan Planning Organization's Active Transportation Plan; and,

**WHEREAS**, the *City Council of the City of Laredo* designates the City Manager as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter, or terminate the gran on behalf of the applicant agency.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS THAT:**

**SECTION 1.** Authorizing the City Manager to submit an application in the amount of \$1,250,000.00 to the Laredo & Webb County Area Metropolitan Organization (LWCAMPO), under the 2025 Transportation Alternatives (TA) Set-Aside Program for the design, engineering, testing and construction of Independence Hills Park – Summers Trails, and to execute all relevant

documents as determined by TxDOT. The project will provide, promote and support mobility enhancement, connectivity, accessibility and community safety goals. This notice of funding opportunity is on a reimbursement basis. Grant match of 20% in the amount of \$250,000.00 is available in District 1 priority funds and 2015 Certificate of Obligation and Environmental 2019 Certificate of Obligation.

**SECTION 2.** This Resolution shall take effect immediately upon passage.
