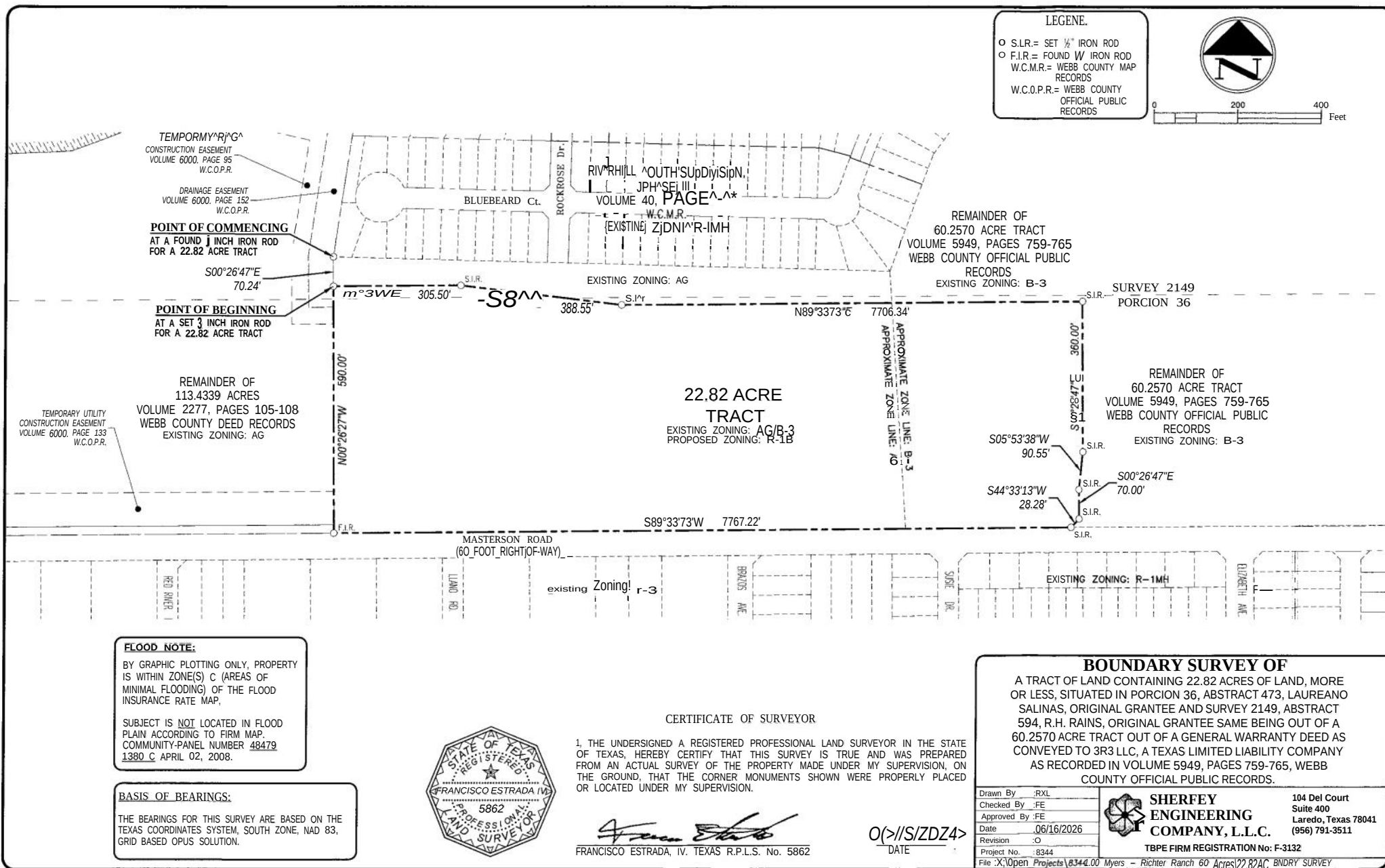

**COMMENCING** at a found 1/2 inch iron rod at the southwest corner of Riverhill South Subdivision Phase III as recorded in Volume 40, Pages 63-64, Webb County Map Records same being the northwest corner of a 60.2570 acre tract as recorded in Volume 5949, Pages 759-765, Webb County Official Public Records;

**THENCE**, S 00°26'47" E, along the common property line with said 60.2570 acre tract a distance of 70.24 feet to a set 1/2 inch iron rod, the **POINT of BEGINNING** and northwest corner of the herein described tract;

**THENCE**, N 89°33'13" E, a distance of 305.50 feet to a set 1/2 inch iron rod, a deflection right;

**THENCE**, S 83°03'11" E, a distance of 388.55 feet to a set 1/2 inch iron rod, a deflection left;

**THENCE**, N 89°33'13" E, a distance of 1,106.34 feet to a set 1/2 inch iron rod, the northeast corner of the herein described tract;

**THENCE**, S 00°26'47" E, a distance of 360.00 feet to a set 1/2 inch iron rod, a deflection right;

**THENCE**, S 05°53'38" W, a distance of 90.55 feet to a set 1/2 inch iron rod, a deflection left;

**THENCE**, S 00°26'47" E, a distance of 70.00 feet to a set 1/2 inch iron rod, a deflection right;

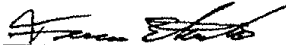
**THENCE**, S 44°33'13" W, a distance of 28.28 feet to a set 1/2 inch iron rod, a point on the north right-of-way line of Masterson Road (a 60 foot wide right-of-way), the southeast corner of the herein described tract;

**THENCE**, S 89°33'13" W, along the north right-of-way line of said Masterson Road a distance of 1,767.22 feet to a set 1/2 inch iron rod, the southwest corner of the herein described tract;

**THENCE**, N 00°26'27" W, along the common property of said 60.2570 acre tract and the remainder of a 113.4339 acre tract as recorded in Volume 2277, Pages 105-108, Webb County Deed Records a distance of 590.00 feet to return to and close at the **POINT of BEGINNING**, containing 22.82 acres of land.
