ACCEPTING THE CONVEYANCE OF A PERMANENT TWENTY (20) FOOT WIDE UTILITY EASEMENT AND THIRTY (30) FOOT WIDE TEMPORARY CONSTRUCTION EASEMENT FROM KILLAM RANCH PROPERTIES, LTD., TO FACILITATE THE CONSTRUCTION OF THE TWENTY-FOUR (24) INCH WATER TRANSMISSION MAIN.

WHEREAS, the City of Laredo-Utilities Department is requesting from Killam Ranch Properties, Ltd., a permanent twenty (20) foot wide permanent easement, with 185 square feet more or less for the installation of the twenty (24) inch water transmission main, along with a thirty (30) foot temporary construction easement, with 704 square feet more or less, situated in porcion 30, Abstract 469, Jose Francisco Cordova Moreno Original Grantee as recorder in Volume 1385, Pages 300-301, W.C.P.R. City of Laredo, Webb County, Texas. Being more particularly described by the attachment exhibit "A" and "B" attached hereto and made part of, providing for an effective date, and

WHEREAS, the City of Laredo is requesting said easement from Killam Ranch Properties, Ltd., for the construction of a twenty-four (24) inch water transmission main needed in order to provide water to south Laredo, and

WHEREAS, the Killam Ranch Properties, Ltd., is the property owner wherein the requested services and easement is needed, and

WHEREAS, the Temporary Construction Easement for the installation of the twenty-four (24) inch water transmission main will provide access and use of the area to facilitate construction activities via temporary property during the construction time, and

WHEREAS, the grantee shall have the right to remove all trees, undergrowth, and other obstruction which may be located within the utility easement that may injure endanger, or interfere with the construction, operations, maintenance and repair of said utility water line, and

WHEREAS, it is in the best interest of the City of Laredo to accept the easement from Killam Ranch Properties, Ltd., as described in the attached Exhibit A and B.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

<u>Section 1.</u> It authorizes the City Manager to accept a twenty (20) foot wide permanent utility easement and thirty (30) foot wide temporary construction easement from Killam Ranch Properties, Ltd., recorded in Volume 1385 Pages 300-301, deed records Webb County, Texas; particularly described in the attached Exhibit "A" and "B
