ORDINANCE NO. 2025-O-____

AN ORDINANCE OF THE CITY OF LAREDO, TEXAS, AMENDING CHAPTER 19, ARTICLE VIII, SECTION 19-364, OF THE CODE OF **ORDINANCES BY ADDING SUBSECTION (30), RESTRICTED PARKING** AREAS TO INLCUDE NO PARKING, STANDING, AND STOPPING, ANYTIME TOW AWAY ZONE, AND **TEMPORARY** LOADING/UNLOADING, AND NO OVERNIGHT PARKING BETWEEN 10 P.M. AND 6 A.M. ON BOTH THE NORTH AND SOUTH SIDE OF 12000 **BLOCK OF RIVERBANK DRIVE BETWEEN IH-69W FRONTAGE ROAD** AND FM 1472; PROVIDING THAT THIS ORDINANCE SHALL BE **CUMULATIVE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING** FOR PUBLICATION; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, the City of Laredo is a Home Rule City acting under its Charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Local Government Code; and

WHEREAS, the City Council desires to establish no parking, standing, and stopping, anytime and tow away zone, temporary loading/unloading, and no overnight parking between 10 P.M. and 6A.M. on both the north and south side of 12000 block of riverbank drive between ih-69w frontage road and FM 1472.; and;

WHEREAS, he City of Laredo is of the opinion that amendment of this ordinance will benefit the community as well as the general health and safety of the public at large.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS THAT:

<u>Section 1.</u> The City of Laredo Code of Ordinances, Chapter 19, Article VIII, section 19-364 is hereby amended as follows:

Sec. 19-364. Restricted Parking Areas

(30) No parking, standing, and stopping, anytime and tow away zone, temporary loading/unloading, and no overnight parking between 10 P.M. and 6A.M. on both the north and south side of 12000 block of riverbank drive between ih-69w frontage road and FM 1472.

<u>Section 2.</u> This ordinance shall be cumulative of all provisions of ordinances of the City of Laredo, Texas, except where the provisions of this ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

<u>Section 3.</u> It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs and sections of this ordinance are severable, and if any phrase, clause,

sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

<u>Section 4.</u> The City Secretary of the City of Laredo is hereby directed to publish the proposed Ordinance as required by Section 2.09 of the Charter of the City of Laredo.

<u>Section 5.</u> This Ordinance shall become effective immediately upon passage.
