

**CONTINUED AGREEMENT FOR RYAN WHITE PART
D SUBCONTRACT BETWEEN VALLEY AIDS
COUNCIL D/B/A WESTBROOK CLINIC AND CITY OF
LAREDO HEALTH DEPARTMENT**

PURPOSE: This is a Continued Agreement entered into between Valley AIDS Council d/b/a Westbrook Clinic (VAC) and the City of Laredo Health Department. This Continued Agreement is for the Ryan White Part D Subcontract between Valley AIDS Council d/b/a Westbrook Clinic and City of Laredo Health Department that was effective from August 1, 2025, through July 31, 2026.

WHEREAS the original Agreement contemplated and by its own terms provided that the original 2019 to 2020 Agreement could be amended if mutually agreed upon and if the Amendment was executed by all parties.

WHEREAS, VAC and the City of Laredo Health Department (City), by mutual agreement and by execution of the First Amendment extended the original agreement to make it effective for an additional year.

WHEREAS, VAC and the City of Laredo Health Department (City), by mutual agreement and by execution of this Amendment wish to again extend the original agreement to make it effective for an additional year.

TERM OF CONTINUED Agreement: The term of this Agreement shall extend the original Agreement from August 1, 2025, through July 31, 2026.

CONTINUED AMENDMENT: City agrees that the terms and conditions of payment remain the same. The award amount for 2025-2026 is \$26,880. VAC shall compensate City as outlined in the original Agreement subject to the conditions set forth in the original Agreement. City will furnish and provide Ryan White Part D Services. City's Reporting and Accountability requirements set forth in the original Agreement remain the same to include completing and submitting the requisite FFATA CERTIFICATION, establishing the requisite safeguards set forth in the original Agreement as well as complying with all other terms and conditions set forth in the original Agreement attached as an Exhibit hereto as well as complying with all laws, regulations, and program requirements.

SCOPE OF WORK: City will continue to provide Ryan White Part D Services, submit the required reports, and otherwise perform and provide Part D Services for Women, Infants, Children, and Youth in accordance with Ryan White HIV/AIDS Program requirements.

GENERAL. Except as specifically amended herein, all Terms and Conditions of the original Agreement shall remain in full force and effect.

IN WITNESS HEREOF, Valley AIDS Council and the City of Laredo Health Department, by and through their duly authorized representatives by mutual agreement and by executing this Amendment through their duly authorized representatives hereby amend and extend the original Agreement as set forth herein.
