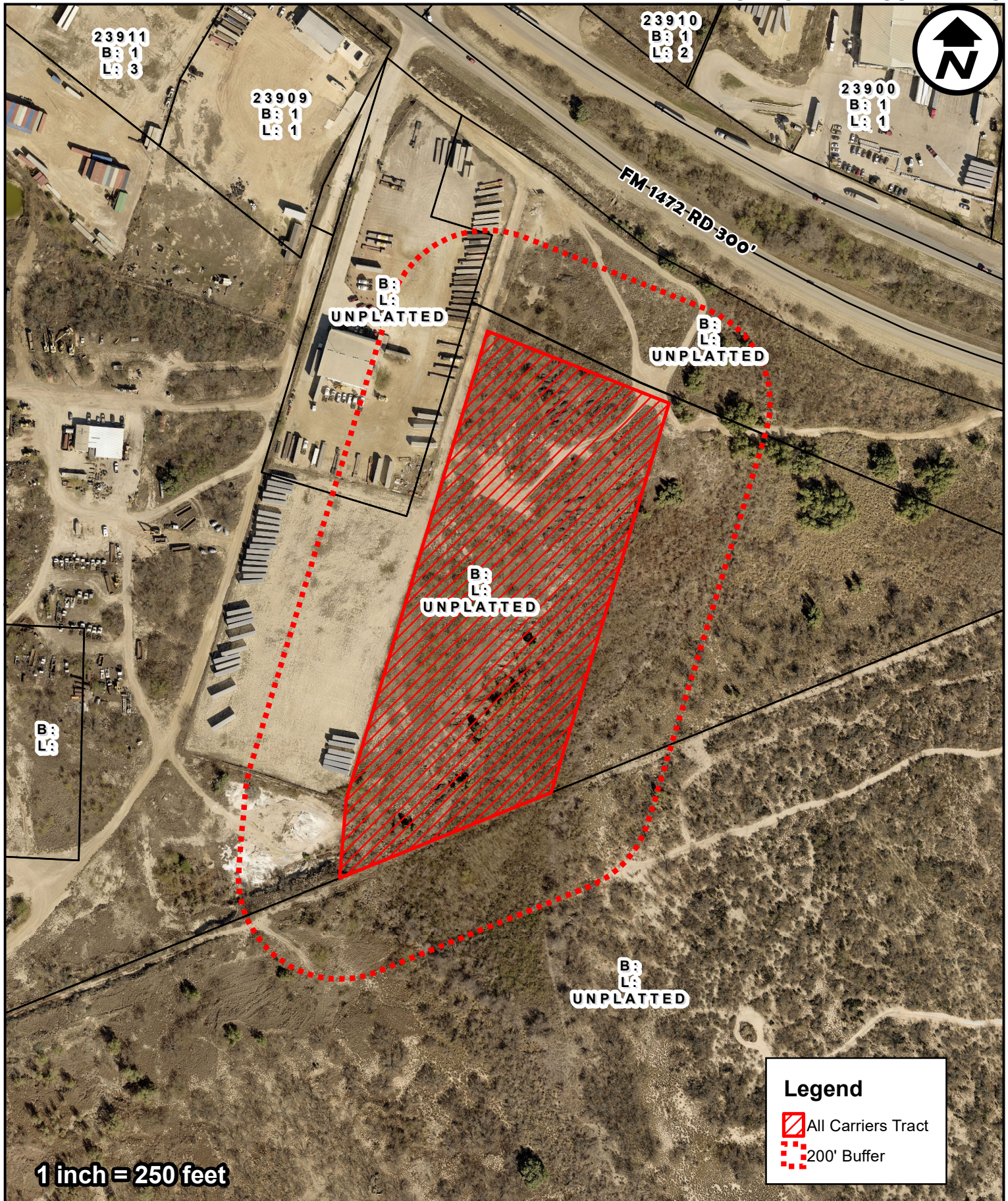


AERIAL MAP

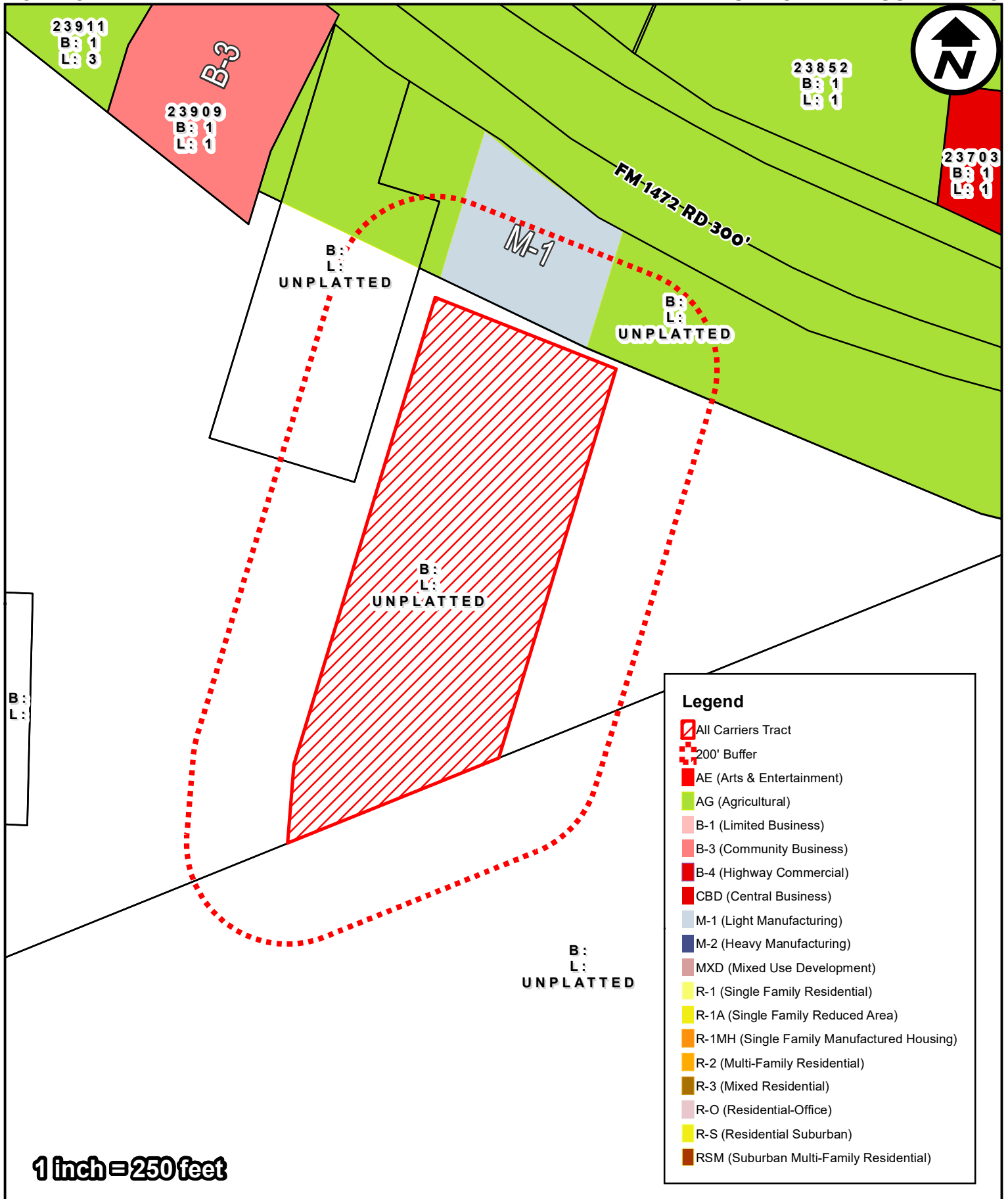

Commencing at a ½" iron rod found at the northwest corner of a tract of land conveyed by deed to All Carriers, Inc, recorded in Volume 5176, Page 110, Official Public Records, Webb County, Texas, continue **South 16 degrees 49 minutes 34 seconds West, 290.54 feet**, to a ½" inch iron rod found at the **Point of Beginning**, for the northwest corner of the herein described tract;

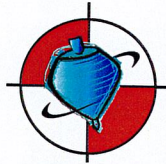

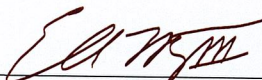
