Award Executive Summary

The City of Laredo is applying for FY2022 Section 5307 formula federal grant funds in the amount of \$ 4,454,205. The grant will consist for the purchase of 7-35FT. Heavy-Duty ADA CNG Buses, 25- Bus Farebox, 2-Support Vehicles, and Equipment, 1-Backup Generator for the CNG Plant and 9 ADA Screen Monitors.

The grant purchases will be utilizing the use of federal funds primarily for the fixed-route services for the City of Laredo public transportation provider - the Laredo Transit Management Inc. (LTMI).

The new buses will be replacing seven (7) 2009 Gilling Buses that have reached its lifetime Useful Life and met the minimum Useful Life Benchmark both in lifetime miles of 500,000 and the 12 years lifetime. The bus farebox are now obsolete and the manufacturer no longer will be manufacturing parts.

The new backup generator is for the CNG Plant in case of any power outages the plant will continue to operate while the ADA Screen monitors are for inside the buses that will be for bus route information to the riders. Last, this project includes the procurement of two (2) support vehicles for the Operations and Maintenance Departments. The total local match for this grant application in the amount of \$839,116 will be locally matched by the dedicated Transit's 1/4 percent sales tax. In addition, the ADA CNG heavy-duty buses meet the 85/15 threshold for the match and all other capital equipment will be an 80/20 match.

Purpose: The purpose of this project is to continue bus operations by acquiring capital replacement for 7 heavy-duty CNG buses, upgrade of 25 fareboxes, and 2 support vehicles, 1 generator and 9 ADA Screen Monitors.

Activities to be performed: Funds will be used to cover eligible replacement and new capital equipment for the bus operations of El Metro.

Expected Outcomes: Funding will permit the Laredo Transit to still continue its Capital Replacement Plan by acquiring buses including safety and security equipment that have reached its useful lifetime expectancy.

The new backup generator is for the CNG Plant in case of any power outages the plant will continue to operate while the ADA Screen monitors are for inside the buses that will be for bus route information to the riders. The total local match for this grant application in the amount of \$839,116 will be locally matched by the dedicated Transit's 1/4 percent sales tax. In addition, the ADA CNG heavy-duty buses meet the 85/15 threshold for the match and all other capital equipment will be an 80/20 match.

The city will expense at a minimum 1% for security equipment in the new buses which also have safe features for the riders and especially to the EI Metro drivers. Security expenditure of 1% will be met for costs related to surveillance equipment installed on the buses. For the 0.75% Safety Requirement, the City of Laredo will use funds for Safety Committee activities to implement safety measures as required such as operator safety, on call security measures, review and revision of the System Safety Program Plan (SSPP), Security and Emergency Preparedness Plan (SEPP), and documentation related to Hazard Management, Accident and Incident Investigation, Internal Safety and Security Assessments and Corrective Action Plans.

Safety expenditures will be met for costs related to safety equipment also installed on the buses.

Research and Development: This award does not include research and development activities.

Indirect Costs: This award does not include an indirect cost rate.
