

RESOLUTION 2024-R-305

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS, AUTHORIZING THE CITY MANAGER TO ACCEPT A GRANT IN THE AMOUNT OF \$21,462.73 FROM THE OFFICE OF THE GOVERNOR, PUBLIC SAFETY OFFICE, CRIMINAL JUSTICE DIVISION FOR THE FY2025 VIOLENCE AGAINST WOMEN JUSTICE AND TRAINING PROGRAM GRANT FOR THE PERIOD OF OCTOBER 01, 2024 THROUGH SEPTEMBER 30, 2025. THIS GRANT WILL PROVIDE FUNDING FOR CRIMES AGAINST WOMEN TRAINING INTENDED FOR LAREDO POLICE DEPARTMENT PERSONNEL. THE CITY OF LAREDO WILL BE RESPONSIBLE FOR THE REQUIRED MATCH OF \$9,198.32, FROM GENERAL FUND, FOR A GRANT TOTAL OF \$30,661.05. GRANT FUNDING IS AVAILABLE IN THE SPECIAL POLICE FUND.

Whereas, the Office of the Governor, Criminal justice Division and the Laredo Police Department will provide training for Laredo PD personnel; and

Whereas, the City of Laredo designates the City Manager as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter or terminate this grant on behalf of the City of Laredo; and

Whereas, the City of Laredo agrees to provide applicable matching funds for the said project as required by the Office of the Governor, Criminal Justice Division grant application; and

Whereas, the City of Laredo agrees that in the event of loss or misuse of the Office of Governor funds, the City of Laredo assures that the funds will be returned to the Office of the Governor in full.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

SECTION 1: Authorizing the City Manager to accept a grant in the amount of \$21,462.73 from the Office of the Governor, Public Safety Office, Criminal Justice Division for the FY2025 Violence Against Women Justice and Training Program Grant for the period of October 01, 2024 through September 30, 2025. This grant will provide funding for Crimes Against Women training intended for Laredo Police Department personnel. The City of Laredo will be responsible for the required match of \$9,198.32, from General Fund, for a grant total of \$30,661.05.

SECTION 2: It authorizes the City Manager to execute all necessary forms and documents to obtain said grant and to effectuate its items.
