A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS, AUTHORIZING THE CITY MANAGER TO ACCEPT AND ENTER INTO A CONTRACT AMENDMENT FROM TEXAS HEALTH AND HUMAN SERVICES COMMISSION (HHS) FOR THE TITLE V CHILD HEALTH AND DENTAL SERVICES PROJECT GRANT, FOR A DECREASE IN FUNDS IN THE AMOUNT OF \$40,902.00, FOR A NEW TOTAL AWARD OF \$13,634.00, WITH NO MATCH FOR THE CITY OF LAREDO PUBLIC HEALTH DEPARTMENT FOR THE TERM PERIOD FROM SEPTEMBER 01, 2025 THROUGH AUGUST 31, 2026. FUNDS WILL BE ACCOUNTED FOR IN THE LAREDO PUBLIC HEALTH DEPARTMENT FUND – TITLE V CHILD HEALTH AND DENTAL SERVICES PROJECT GRANT.

WHEREAS, The Texas Health and Human Services Commission continues to contract with the City of Laredo to provide public health preventive and screening patient care services for the uninsured, underserved and medically indigent of Laredo through the City of Laredo Public Health Department. Funding provided through these grants supports prenatal, preventive, and primary women’s health care services for eligible women, including limited dysplasia services, as well as newborn care and dental and preventive services for eligible children and adolescents. The program will bill Title V or Medicaid for all eligible services and will reinvest all program income generated through Medicaid to expand and enhance women’s health services, including maternal and preventive care, children’s health services, and preventive and chronic disease services for men and families. These efforts ensure the delivery of quality wellness and preventive health care services to underserved, uninsured, and medically indigent populations.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

Section 1: The City Manager is hereby authorized to accept and enter into a contract amendment from the Texas Health and Human Services Commission (HHS) for the Title V Child Health and Dental Services Project Grant, for a decrease in funds in the amount of \$40,902.00, for a new total award of \$13,634.00, with no match for the City of Laredo Public Health Department for the term period from September 01, 2025 through August 31, 2026. Funding is available in the Title V Child Health and Dental Services Project Grant.

Section 2: Funding is available in revenue account 226-0000-323-4047 and the expenditure division is 226-6016 with project number HEDE18.
