RESOLUTION 2024-R-190

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS, AUTHORIZING THE CITY MANAGER TO SUBMIT A GRANT APPLICATION IN THE AMOUNT OF \$5,226,346.40 TO THE DEPARTMENT OF HOMELAND SECURITY (DHS) AND THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) FOR THE SHELTER AND SERVICES PROGRAM (SSP-C). IF AWARDED, THIS GRANT WILL PROVIDE SERVICES TO INDIVIDUALS AND FAMILIES RELEASED FROM DHS CUSTODY. THERE IS NO COST SHARE REQUIREMENT. THE GRANT WILL BE ACCOUNTED FOR IN THE GENERAL FUND BUDGET-FIRE DEPARTMENT.

Whereas, the City of Laredo finds it in the best interest of the citizens of Laredo, that the FEMA Shelter and Services Program (SSP-C) be accepted; and

Whereas, the City Council designates the City Manager as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter, or terminate this grant on behalf of the City of Laredo; and

Whereas, the City of Laredo agrees that in the event of loss or misuse of the Federal Emergency Management Agency (FEMA) SSP-C funds, the City of Laredo assures that the funds will be returned in full and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

Section 1: Authorizing the City Manager to submit a grant application in the amount of \$5,226,346.40 to the Department of Homeland Security (DHS) and the Federal Emergency Management Agency (FEMA) Shelter and Services Program (SSP-C). If awarded, this grant will provide services to individuals and families released from DHS custody. There is no cost share requirement. The grant will be accounted for in the General Fund Budget—Fire Department.

Section 2: It authorizes the City Manager to execute all necessary documents to achieve said grant and to effectuate its terms.
