
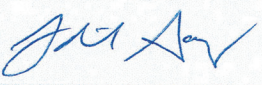

Field Notes

**For a 2.66-acre tract of land out of Lot 3A, Block 3, Cielito Lindo Commercial Plat
Webb County, Texas**

Being a 2.66-acre tract of land out of Lot 3A, Block 3, Cielito Lindo Commercial Plat recorded in Volume 41, page 20, Webb County Plat Records and fronting the northerly Cielito Lindo Boulevard Right-of-Way line.

Beginning at a $\frac{1}{2}$ " *rod* found, being the southwest corner of mentioned Lot 3A, same being the southeast corner of Lot 2, Block 3, Cielito Lindo Commercial Plat recorded in Volume 23, page 56, Webb County Plat Records, same being a point along the north Cielito Lindo Boulevard Right-of-Way and going *North 00°30'43" West, 392.06 feet* to a $\frac{1}{2}$ " *iron rod* found being the northwest of mentioned Lot 3A, and the northeast corner of mentioned Lot 2 and a point along the southerly line of a tract of land conveyed to Cayetano Development, LLC described in deed recorded in Volume 5134, page 230, Public Records, Webb County, Texas, for the northwest corner hereof;

Thence, with the southerly line of said Cayetano Development, LLC tract and northerly line of said Lot 3A, *North 89° 43' 02" East, 296.47 feet* to a point along said Cayetano Development, LLC tract and point along said Lot 3A, for the northeast corner hereof;

Thence, through said Lot 3A, *South 00° 30' 43" East, 390.88 feet* to a point along the northerly Cielito Lindo Boulevard Right-of-Way line and point along said Lot 3A, for the southeast corner hereof;

Thence with the northly Right-of-Way line of Cielito Lind Boulevard, *South 89° 29' 17" West, 296.47 feet* to the Point of Beginning and containing 2.66-acres of land, more or less.

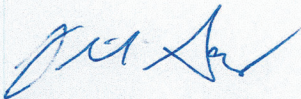
