A RESOLUTION OF THE CITY COUNCIL OF THE CITY **TEXAS AUTHORIZING** LAREDO, THE MANAGER TO SUBMIT THE 2024-2025 ONE YEAR ACTION PLAN TO U.S. DEPARTMENT OF HOUSING AND **DEVELOPMENT** URBAN (HUD), **REQUEST** FUNDING IN THE AMOUNTS OF \$3,032,219.00 IN THE **50TH ACTION YEAR COMMUNITY DEVELOPMENT** BLOCK GRANT (CDBG) FUNDS, \$957,641.00 THROUGH THE HOME INVESTMENT PARTNERSHIP PROGRAM, AND \$283,641.00 THROUGH THE **EMERGENCY** SOLUTIONS GRANT (ESG). AN ADDITIONAL \$80,000.00 IS ANTICIPATED TO BE RECEIVED IN HOUSING REHABILITATION REVOLVING LOAN FUNDS. AND \$125,000.00 IN HOME PROGRAM INCOME. ALSO AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS AS ARESULT OF THE PLAN'S SUBMISSION.

Whereas, the City of Laredo Community Development Department hosted it's 1st public hearing on April 2nd, 2024 to allow public and City Council to submit recommendations for projects for the 2024-2025 One Year Action Plan. No comments were received.

Whereas, the City of Laredo Community Development Department hosted it's 2nd public hearing on June, 2024 providing interested citizens an opportunity to comment on the draft One Year Action Plan. The period of time to review the plan and provide comments was from May 29th to June 28th, 2024. No comments were received.

Whereas, the *City council of the City of Laredo* designates the City Manager as the grantee's authorized official. The authorized official is given the power to execute any required documents as requested by HUD.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

Section 1: Authorizing the City Manager to submit the 2024-2025 One Year Action Plan to U.S. Department of Housing and Urban Development (HUD), request for funding in the amounts of \$3,032,219 in 50th Action Year Community Development Block Grant (CDBG) funds, \$957,641.00 through the HOME Investment Partnership Program, and \$283,641 through the Emergency Solutions Grant (Grant). An additional \$80,000.00 is anticipated to be received in Housing Rehabilitation Revolving Loan funds, and \$125,000.00 in HOME Program Income.

Section 2: This Resolution shall take effect immediately upon passage.
