Dear Ms. Maldonado:

Introduction

On August 27, 2025, you were notified of the 2025 Webb County Appraisal District Board of Director's Election pursuant to Section 6.0301 of the Texas Property Tax Code. The governing bodies of the taxing units participating in the Appraisal District for the 2026-2029 term are the City of Laredo and United Independent School District. The letter included Director candidate eligibility requirements and information, a voting entitlement schedule, and an election planning calendar. As a courtesy, I have enclosed an updated schedule and calendar for easy access and reference.

Official Ballot

Before October 30th, the Chief Appraiser is required to accept, list, and deliver candidate nomination information to the taxing units for the two (2) of the five (5) Board positions of the Appraisal District. **The candidates are listed alphabetically in a prepared ballot as required by law.** The Official Voting Ballot is enclosed for your reference and action. **Please take action, by resolution, to cast your voting entitlement for the candidates listed on the ballot and forward the resolution to the Chief Appraiser by the deadline, as required by State law.**

The submission deadline for the voting resolution is before December 15, 2025, or sooner. Additionally, for your review and consideration, enclosed is a copy of a sample resolution.

Next Step

The Chief Appraiser has completed the voting ballot notification requirements with this letter. Your next step is to proceed with **casting your voting entitlement** for the candidate(s) listed on the "Official Voting Ballot" for submission, **by resolution, from your governing body** to the Chief Appraiser **before December 15, 2025, or sooner. Please reference your taxing unit's total number of voting entitlement for this election process.**

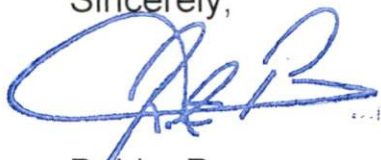
Election Results

Upon receiving the taxing unit's voting resolution, the Chief Appraiser shall count the votes, declare the two (2) candidates appointed and submit the results to the taxing units and candidates **before December 31st. The two (2) candidates with the largest cumulative vote totals are the appointed Board members.** Pursuant to State law, the Chief Appraiser will resolve a tie vote by any method of chance. **Two (2) appointed directors will serve a term of four (4) years (Beginning January 1, 2026, and ending December 31, 2029).**

Conclusion

Thank you for your attention to this Board selection process. Please note that I am available to your governing body or administration if your agency desires my assistance or a presentation. I am awaiting your action and response, **by resolution, before the December 15th deadline pursuant to State law.**

Before October 1 st	<u>COMPLETED 8/27/2025</u>	Chief Appraiser shall calculate and deliver written notice of voting entitlement to each taxing unit entitled to vote on Appraisal District Director positions.
Before October 15 th	<u>COMPLETED 10/15/2025</u>	Each taxing unit entitled to vote may nominate <u>by resolution</u> adopted by its governing body one candidate for each positions to be filled on the Appraisal District Board of Directors. You may nominate up to 5 candidates. <u>Resolution</u> must be submitted to the Chief Appraiser by the deadline.
Before October 30 th	<u>COMPLETED 10/22/2025</u>	Chief Appraiser shall prepare a ballot listing the candidates alphabetically whose names were timely submitted and deliver it to the presiding officer of the governing body of each taxing unit.
Before December 15 th	_____	The governing body of each taxing unit entitled to vote shall select its candidate(s) and cast its votes <u>by resolution</u> and submit it to the Chief Appraiser by the deadline.
Before December 31 st	_____	The Chief Appraiser shall count the votes, declare the five candidates and submit the results to the governing body of each taxing unit and to the candidates. The Chief Appraiser shall resolve a tie vote by any method of chance
