A 0.42 ACRE TRACT, MORE OR LESS, OUT OF A TRACT OF LAND CONVEYED TO D & J ALEXANDER INVESTMENTS, LLC, RECORDED IN VOLUME 4164, PAGES 705-710, OFFICIAL PUBLIC RECORDS, WEBB COUNTY, TEXAS, SITUATED IN PORCION 26, AGUSTIN SANCHEZ, ORIGINAL GRANTEE, ABSTRACT 282 WITHIN THE CITY OF LAREDO, WEBB COUNTY TEXAS.
