

Good evening, Ez

We are getting ready for approvals with council, and I wanted to follow up with you on a couple details I noticed while reviewing the 2010 grant.

First, would you happen to know if we will need additional parts, such as Photo Cell Receptacles, LED Adapters, and Photo Cells? I just saw them now while reviewing the previous grant purchase, and I wanted to make sure we are accounting for those if needed. Our Traffic Department is finally conducting an assessment of the proposed light posts to be fixed, so they might provide more specific information on what's needed. In any case, I thought I'd run it through you as well, since I hadn't flagged it with them yet. I know the retrofit was more drastic back in 2010, so I wouldn't be surprised if the current infrastructure is more easily adaptable to this model.

Also, do you happen to have a Build America, Buy America (BABA) Certification Letter for the LED streetlights we will be purchasing? I came across a Buy American Certification Letter for 2009, and I wanted to check in with you if you all have something similar for BABA. I know they're different legislations, but I'm attaching a redacted sample for your records.
