

Being a 3.05 acre tract of land out of a 3.30 acre tract of land conveyed to Jose Julio Gutierrez and wife, Judith Elena Gutierrez, described in deed recorded in Volume 5027, Pages 73-78, Official Records, Webb County, Texas, situated in Porcion 10, Tomas Sanchez, Abstract 280, Webb County, Texas, and being more particularly described by metes and bounds as follows, to wit:

Beginning at a *point* at the City of Laredo city limits line at a northeasterly line of a tract of land conveyed to Albert Sosa III, described in deed recorded in Volume 4471, Pages 667-669, Official Records, Webb County, Texas, which bears North 22 degrees 20 minutes 29 seconds West, 47.67 feet from a ½" iron rod found at the most southerly corner of said Jose Julio Gutierrez tract, for the southwest corner hereof;

Thence, with an easterly line of said Sosa tract, *North 22 degrees 20 minutes 29 seconds West, 435.33 feet* to a ½" *iron rod* found at the southeasterly Right of Way line of FM 1472 (Old Mines Road), for the northwest corner hereof;

Thence, with the southeasterly Right of Way line of said FM 1472, North 68 degrees 06 minutes 53 seconds East, 279.25 feet to a ½" iron rod found at a westerly line of aforementioned Sosa tract, for the northeast corner hereof;

Thence, with a westerly line of said Sosa tract, South 29 degrees 09 minutes 11 seconds East, 438.76 feet to a point at the aforementioned City of Laredo city limits line from which the remains of a cedar post found at an interior corner of said Sosa tract bears South 29 degrees 09 minutes 11 seconds East, 17.45 feet, for the southeast corner hereof:

Thence, with said City of Laredo city limits line, South 68 degrees 05 minutes 56 seconds West, 331.29 feet to the Point of Beginning and containing 3.05 acres of land, more or less.
