

RESOLUTION NO. 2025-R-53

AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF LAREDO AND THE WEBB COUNTY-CITY OF LAREDO REGIONAL MOBILITY AUTHORITY (WC-CL RMA) FOR CONCORD HILLS ALIGNMENT PROJECT. THE WC-CL RMA WILL BE PARTICIPATING WITH FUNDING FOR THE PROJECT IN THE AMOUNT NOT TO EXCEED \$1,000,000.00 PLUS AN ADDITIONAL \$325,000.00 FROM THE WEBB COUNTY DRAINAGE DISTRICT NO. 1 FOR A TOTAL AMOUNT OF \$1,325,000.00 TO DEVELOP AND CONSTRUCT A 1.3-MILE EXTENSION OF CONCORD HILLS BOULEVARD FROM LOS PRESIDENTES AVENUE TO THE WORMSER ROAD/ LOMAS DEL SUR BOULEVARD EXTENSION.

WHEREAS, the WC-CL RMA is a regional mobility authority created pursuant to the request of Webb County and the City of Laredo and operating pursuant to Chapter 370 of the Texas Transportation Code (the “RMA Act”) and 43 TEX. ADMIN. CODE §§ 26.1, *et seq.* (the “RMA Rules”), and is a body politic and corporate and political subdivision of the State of Texas; and

WHEREAS, Chapter 791 of the Texas Government Code provides that any one or more public agencies may contract with each other for the performance of governmental functions or services in which the contracting parties are mutually interested; and

WHEREAS, Section 370.033 of the Transportation Code provides that a regional mobility authority may enter into contracts or agreements with another governmental entity; and

WHEREAS, the Parties support the extension of Concord Hills Boulevard (Concord Hills) for approximately 1.3 miles to the Wormser Road/Lomas Del Sur Boulevard Extension (the “Concord Hills Project”); and

WHEREAS, on September 21, 2022, in Resolution No. 22-25, the WC-CL RMA Board of Directors authorized the WC-CL RMA Chair to execute an agreement with the City of Laredo and other entities to contribute to the cost of the Concord Hills Project; and

WHEREAS, the Parties agree that the extension of Concord Hills will benefit the residents of the City of Laredo and Webb County by increasing mobility in the South Texas region.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the undersigned Parties agree as follows:

SECTION 1. The City Manager is authorized to execute an Interlocal Agreement (ILA) with the Webb County-City of Laredo Regional Mobility Authority (WC-CL RMA) to develop and construct a 1.3-mile extension of Concord Hills Boulevard from Los Presidentes Avenue to the Wormser Road/ Lomas Del Sur Boulevard Extension, including any minor amendments thereto.

SECTION 2. The WC-CL RMA will be participating with funding for the project in the amount not to exceed \$1,000,000.00 plus an additional \$325,000.00 from the Webb County Drainage

District No. 1 for a total amount of \$1,325,000.00
