

## **RESOLUTION 2025-R-100**

### **REPEAL OF RESOLUTION NO. 2025-R-22 AND SUBSEQUENT AMENDMENTS**

**A RESOLUTION OF THE CITY OF LAREDO, TEXAS REPEALING RESOLUTION 2025-R-22 OF THE CITY OF LAREDO. RESOLUTION 2025-R-22 ESTABLISHED THE PURCHASE OF A 6 FOOT WIDE UTILITY AND ACCESS EASEMENT LOCATED WITHIN A TRACT CALLED 11.2897 ACRE TRACT OF LAND DESCRIBED AS TRACT II IN AN INSTRUMENT TO GAR-RAM INVESTMENTS, LTD., RECORDED IN DOCUMENT NO. 916105, OFFICAL PUBLIC RECORDS OF WEBB COUNTY, TEXAS. REPEALER, SEVERABILITY, CODIFICATION AND EFFECTIVE DATE, AND FINDING PROPER NOTICE AND MEETING.**

**WHEREAS**, the City Council of the City of Laredo finds that on January 28,2025 the City Council approved Resolution 2025-R-22 which approved to negotiate and purchase of a 6 foot wide Utility and Access Easement from Gar-Ram Investments Ltd.

**WHEREAS**, Gar-Ram Investments has agreed to convey said easement and the City of Laredo has agreed to designate a service lateral to allow Gar-Ram Investments Ltd. to connect to the gravity line in the future at no cost to Gar-Ram Investments Ltd.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:**

#### **Section 1: REPEAL OF RESOLUTION 2025-R-22.**

City of Laredo Resolution 2025-R-22 is hereby repealed in its entirety.

#### **Section 2: REPEALER**

All ordinances, resolutions, or parts thereof, that are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters regulated, herein.

#### **Section 3: SEVERABILITY**

Should any of the clauses, sentences, paragraphs, sections or parts of this Resolution be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Resolution.

#### **Section 4. CODIFICATION**

The City Secretary is hereby authorized and directed to record and publish the language of this repealing Resolution, and any changes thereto, in the City's Code of Ordinances.

#### **Section 5. EFFECTIVE DATE**

This Resolution shall be effective immediately upon its passage and publication.
