SETTING THE TEMPORARY CONSTRUCTION SPEED ZONE LIMIT AT SH 255: 55 MPH FROM FM 1472 (MILE POINT 1.000) TO APPROX. 580 FT EAST OF FM 1472 (MILE POINT 10.110/0.110 MILES). TO BE IN EFFECT UPON RECEIPT OF APPROVED CITY RESOLUTION. AS DEFINED IN THE TEXAS DEPARTMENT OF TRANSPORTATION CONTROL SECTION MAP 18-6.

WHEREAS, V.A.T.C.S., Texas Transportation Code 545.356 (b) authorizes the City Council to change the speed limits of any highway or street within the incorporated area of the City; and

WHEREAS, the Texas Department of Transportation is requesting a temporary construction speed zone for the upcoming project on the above-mentioned highway; and

WHEREAS, the Texas Department of Transportation is requesting temporary construction speed zone at SH 255: 55 MPH from FM 1472 (Mile Point 1.000) to Approx. 580 ft east of FM 1472 (Mile Point 10.110 / 0.110 Miles)

And.

WHEREAS, TxDOT will be responsible for the installation of speed limit signs to designate the new speed limits to be in effect upon approval; and

WHEREAS, the implementation of the temporary speed limit changes on the existing section of SH 255 is a positive step in securing the safety of our citizens; and

WHEREAS, the City Council of the City of Laredo supports TX Dot's efforts to request the temporary speed limit changes on SH 255.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

SECTION 1.

That the new speed that shall govern for this roadway will be as follows: SH 255: 55 MPH from FM 1472 (Mile Point 1.000) to Approx. 580 ft east of FM 1472 (Mile Point 10.110 / 0.110 Miles).
