

RESOLUTION 2025-R-257

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS TO CAST 1,039 VOTES FOR COUNCIL MEMBER GILBERT GONZALEZ AS THE CITY OF LAREDO'S CANDIDATE TO THE WEBB COUNTY APPRAISAL DISTRICT BOARD OF DIRECTORS 2026-2029 YEAR TERM COMMENCING ON JANUARY 1, 2026 AS PER THE PASSAGE OF SENATE BILL 2 OF THE 88TH LEGISLATURE IN 2023 AND SECTION 6.03 OF THE TEXAS PROPERTY TAX CODE; AND DIRECTING THE CITY SECRETARY TO TRANSMIT A COPY OF THIS RESOLUTION TO THE CHIEF APPRAISER OF THE WEBB COUNTY APPRAISAL DISTRICT BEFORE DECEMBER 15, 2025.

WHEREAS, pursuant to the passage of Senate Bill 2 of the 88th Legislature in 2023 and Section 6.03 of the Property Tax Code, the City of Laredo has received notice on August 27, 2025 from the Chief Appraiser of the Webb County Appraisal District of the 1,039 number of votes to which the City of Laredo is entitled to; and

WHEREAS, On October 6, 2025, City Council approved Resolution 2025-R-233 nominating Council Member Gilbert Gonzalez as the City of Laredo's candidate to the Webb County Appraisal District Board of Directors for the term commencing on January 1, 2026; and

WHEREAS, On October 22, 2025, we received the Official Voting Ballot from the Chief Appraiser of the Webb County Appraisal District naming all candidates for the 2025 Board of Directors Election; and

WHEREAS, The City is entitled to cast 1,039 votes in total for one or more of the nominated candidates listed in the ballot.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

1. The City of Laredo City Council casts its votes on the official ballot of nominees for the Webb County Appraisal District Board of Directors as follows:
