

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS, AUTHORIZING THE CITY MANAGER TO ACCEPT AND ENTER INTO A CONTINUATION CONTRACT FROM THE DEPARTMENT OF HEALTH AND HUMAN SERVICES FOR HIV CLINICAL HIV/STI PREVENTION IN COMMUNITY HEALTH CENTERS PROGRAM GRANT, IN THE AMOUNT OF \$143,868.00 FOR THE TERM PERIOD JANUARY 01, 2026 TO MAY 31, 2026, AND \$345,283.00 FOR THE TERM PERIOD JUNE 01, 2026 TO MAY 31, 2027, WITH NO MATCH FOR THE CITY OF LAREDO PUBLIC HEALTH DEPARTMENT. FUNDS WILL BE ACCOUNTED FOR IN THE LAREDO PUBLIC HEALTH DEPARTMENT FUND – HIV CLINICAL HIV/STI PREVENTION IN COMMUNITY HEALTH CENTERS PROGRAM GRANT.

WHEREAS, The U.S. Department of Health and Human Services Resources and Services Administration contracts the City of Laredo for continuation of the HIV/STI Prevention in Community Health Centers Grant. Through this program, Laredo Public Health will be able to provide individuals and communities most vulnerable to HIV and STI's with access to comprehensive HIV, STI, and HCV testing as well as expand biomedical prevention access;

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

Section 1: The City Manager is hereby authorized to accept and enter into a continuation contract from the Department of Health and Human Services for the HIV Clinical HIV/STI Prevention in Community Health Centers Program Grant, in the amount of \$143,868.00 for term period January 01, 2026 to May 31, 2026, and \$345,283.00 for term period June 01, 2026 to May 31, 2027, with no match for the City of Laredo Public Health Department. Funds will be allocated in the Laredo Public Health Department Fund – HIV Clinical HIV/STI Prevention in Community Health Centers Program Grant.

Section 2: The revenue account 226-0000-323-4012 and the expenditure division is 226-6053 with Project Number HEHI02 and HEHI03.
