Dear Dr. Al-Zabet,

Bids were received Wednesday, July 2, 2025, then opened, and read aloud on Thursday, July 3, 2025, at 10:00 a.m. in the City Secretary's office for the above referenced project. Two (2) bids were received, who were J.S. Haren Company, and RAVA Construction LLC. The apparent low bidder, including constructions and all materials, was RAVA Construction LLC with a **Total Amount** of **\$1,940,000.00**.

Ardurra has reviewed and analyzed the submitted bids, and tabulation of the bid schedules was performed to certify that each bid was entered correctly. The results of this bid tabulation and review are summarized in the attached Bid Tabulation. No discrepancies were found in the bid submitted by RAVA Construction LLC. However, the bid from J.S. Haren Company included a clerical error in Item A1.2, where the unit price in numerical form is shown as the same as the total amount. The unit price was correctly written in words, and the error does not affect the overall bid total.

Ardurra has reviewed the Contractor's bid documents and to its knowledge RAVA Construction LLC has submitted the lowest and responsible bid including constructions and all materials. Ardurra recommends that RAVA Construction LLC **furnish all materials** to help mitigate potential warranty concerns or related issues. Ardurra has performed its due diligence to confirm RAVA Construction LLC resume and past performance. Ardurra has no reason to believe that RAVA Construction LLC will not successfully execute this project. Therefore, it is our recommendation that the City of Laredo award the construction contract for the Zacate Creek Wastewater Treatment Plant Improvements Project to RAVA Construction LLC for the Total Amount of \$1,940,000.00.
