Within the current scope, RAVA will provide JCM 416 T2FW three-piece tapping nozzle with split full wrapper paired with J&S resilient wedge FLxMJ gate valves w/ 150# flange kit and gasket and spur gear.

Following a joint evaluation by our safety department, management team, and **Laredo Jefferson WTP** leadership, the following work plan has been established:

1. Preparation & excavation:

- Remove existing light pole.
- Excavation for a working area of 30' x 20' x 17' with 4 feet steps according to OSHA standards.
- Two ladders will be placed to facilitate entry into the working area.
- Lights to guarantee the correct illumination of the working area.
- Crane available all time.
- OSHA-compliant working area protection and rescue basket.

2. Tapping nozzle:

- Install JCM 416 T2FW three-piece tapping nozzle with split full wrapper paired with J&S resilient wedge FLxMJ gate valves w/ 150# flange kit and gasket and spur gear.
- All lifting equipment, air compressor and small auxiliar equipment.

3. Commissioning & Cleanup:

- Upon completion, the tap system will be tested to confirm proper operation.
