Dear Ms. Lyssy and Mr. Bolaños,

On behalf of City of Laredo – Laredo Transit Management, Inc. (El Metro), I am formally requesting your approval to transfer a total of two (2) transit buses to the following partner agencies:

- **Southwest Area Regional Transit District (SWART) – Eagle Pass, Texas**

The agency has identified an urgent need for additional rolling stock to meet their community's transportation demands. This proposal designates two (2) units for the agency to bolster their fleet capacity and service reliability.

The two units proposed for transfer have exceeded their Useful Life Benchmark (ULB) but remain in operable condition. For your records, these units were originally purchased using Section 5307 funding.

Attached is a detailed list of the specific vehicles, including VINs and current mileage, for your review. We respectfully request your formal authorization to proceed with these transfers to assist our regional transit partners in their mission to provide essential public transportation.
