



## TYPES OF PUBLIC ART

A survey through LAMP revealed the top 3 mediums Laredo residents were most interested in seeing in Laredo.

Any form of art in public spaces, outdoors, and participatory.

Outdoor Artworks 51%

Painted walls, tile, mosaics, utility cabinets, etc.



Murals 15% Installations 20%

Sculptures, light or sound installations, multi-media, traditional statues, etc.

## STANDARD OPERATING PROCEDURES

Establishes a consistent and transparent process for submission, evaluation, and implementation of Laredo's Public Art Program.

### Workflows

Understanding the steps and details of the project process, from proposal intake to artwork maintenance.

### Efficiency

Streamlines the project process, incorporating feedback and regular check-ins during installation to minimize delays and ensure timely completion.

Outlines the roles and duties of all parties involved in the project, ensuring accountability and successful implementation.

# PROJECT TIMELINE

#### Project Launch & **Proposal Submissions**

Public announcement with clear guidelines and support for submitting public art proposal intake forms.

#### **Review & Evaluation**

**Evaluation committee** will score proposals based on artistic merit, impact, feasibility, and qualifications.

### **Approval & Notification**

Committee's recommendations will be sent to city officials, and applicants will be notified of the decision.


