

RESOLUTION 2024-R-252

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS AUTHORIZING THE CITY MANAGER TO ACCEPT AND EXECUTE THE TEXAS VETERANS COMMISSION (TVC) FUND FOR VETERANS' ASSISTANCE (FVA) HOUSING FOR TEXAS HEROES GRANT (H4TXH). THE COMMUNITY DEVELOPMENT DEPARTMENT THROUGH THE MUNICIPAL HOUSING DIVISION RECEIVED AN AWARD IN THE AMOUNT OF \$300,000 TO PROVIDE HOME MODIFICATIONS FOR THE VETERAN COMMUNITY WITHIN THE CITY OF LAREDO AREA. THE TERM OF THE GRANT SHALL BE ONE (1) YEAR FROM JULY 1, 2024 TO JUNE 30, 2025. THERE IS NO MATCH REQUIREMENT AND FUNDING IS AVAILABLE IN THE MUNICIPAL HOUSING FUND.

WHEREAS, the Municipal Housing, a division of Community Development Department, is requesting City Manager accept and execute the grant award in the amount of \$300,000 from the Texas Veterans Commission (TVC) Fund for Veterans Assistance (FVA) Housing for Texas Heroes Grant (H4TXH); and

WHEREAS, this will allow Municipal Housing to provide homeowner veterans or surviving spouse and their families with modification and repairs to their homes; and

WHEREAS, a maximum amount of \$35,000.00 per household assistance to be provided, upon eligibility and meeting all requirements; and

WHEREAS, the Municipal Housing shall go out on bids to contract for home weatherization, modifications and/or repairs to improve roofing, flooring, siding, windows, HVAC, electrical, plumbing, bathroom modifications, entry/exit door modifications and/or ramps in order to assist the veterans or surviving spouse and provide a safe, accessible, and habitable environment;

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO THAT:

Section 1: Authorizing the City Manager to accept and execute the Texas Veterans Commission (TVC) Fund for Veterans' Assistance (FVA) Housing for Texas Heroes Grant (H4TXH).

Section 2: This Resolution shall become effective upon passage thereof.
