**SECOND ADDENDUM TO MEMORANDUM OF UNDERSTANDING**

**WHEREAS**, a Memorandum of Understanding ("Original MOU") was made between the City of Laredo, Texas ("City") and the Housing Authority for the City of Laredo ("LHA") and executed on or about the 26<sup>th</sup> day of March, 2018 (hereinafter referred to as the "Original MOU"), a copy of which is attached hereto and incorporated for all purposes; and

**WHEREAS**, the Original MOU was made pursuant to the operation and implementation of BiblioTech sites in the City of Laredo;

**WHEREAS**, all other terms and conditions of the Original MOU shall remain the same and this Addendum shall hereby become part of the Original MOU; and

**NOW, THEREFORE**, in consideration of the mutual promises herein, the Parties, intending to be legally bound, hereby agree that the following constitutes amendments and additional terms of the stated Original MOU as follows:

1. The LHA will not be financially obligated to pay for applicable fees associated with access by BiblioTech sites to the Library's Integrated Library System ("ILS") to the City of Laredo.
2. The Library will not provide access or support for access to the Library's Integrated Library System ("ILS").
3. The term of this Addendum and the Original MOU will be for an initial three (3) years, with an expiration date of October 1, 2028.
