

RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE TEXAS WATER DEVELOPMENT BOARD UNDER ITS DRINKING WATER STATE REVOLVING FUND (DWSRF) - LEAD SERVICE LINE REPLACEMENT (LSLR) PROGRAM; AUTHORIZING THE FILING OF AN APPLICATION FOR FINANCIAL ASSISTANCE; DESIGNATING CERTAIN AUTHORIZED REPRESENTATIVES OF THE CITY AND APPROVING CERTAIN PROFESSIONALS; AND MAKING CERTAIN FINDINGS IN CONNECTION THEREWITH

WHEREAS, the Laredo, Texas (the "**City**") in Webb County, Texas, is a political subdivision of the State of Texas operating as a Home Rule municipality under the Constitution and laws of the State of Texas; and

WHEREAS, the City Council hereby finds and determines that it is necessary to request financial assistance from the Texas Water Development Board through its Drinking Water State Revolving Fund ("**DWSRF**") – Lead Service Line Replacement ("**LSLR**") program for improvements to the City's waterworks system, including lead service line inventory and replacement (the "**Project**"); and

WHEREAS, it is hereby officially found and determined that public notice of the time, place, and purpose of said meeting was given, all as required by Texas Government Code, Chapter 551;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAREDO, TEXAS:

SECTION 1. REQUEST FOR FINANCIAL ASSISTANCE; APPROVAL OF APPLICATION. The Texas Water Development Board is hereby requested to grant financial assistance through its DWSRF - LSLR program in an amount not to exceed \$44,000,000 to finance the Project, all as further described in the application for financial assistance related to the Project (the "**Application**").

SECTION 2. AUTHORIZED REPRESENTATIVES OF CITY. The City Manager, Finance Director, Budget Director, Utilities Director and City Secretary each are hereby designated as an authorized representative of the City for purposes of furnishing such information and executing such documents as may be required in connection with the preparation and filing of the Application for financial assistance and the rules of the Texas Water Development Board. The City Manager, Finance Director, Budget Director, Utilities Director and City Secretary, together with bond counsel, financial advisor and consulting engineers named in Section 3 below, are hereby authorized to appear before the Texas Water Development Board in support of such Application and the Project. The City Manager, Finance Director, Budget Director, Utilities Director and City Secretary of the City each are further specifically authorized to make corrections and technical

changes to this Resolution and to make the required assurances to the Texas Water Development Board in accordance with the rules, regulations, and policies of the Texas Water Development Board.

SECTION 3. APPROVAL OF PROFESSIONALS. The following firms and individuals are hereby authorized and directed to aid and assist in the preparation and submission of the Application and appear on behalf of and represent the City before any hearing held by the Texas Water Development Board on the Application, to-wit:

SECTION 6. EFFECTIVE DATE. This Resolution shall become effective immediately after its adoption.
