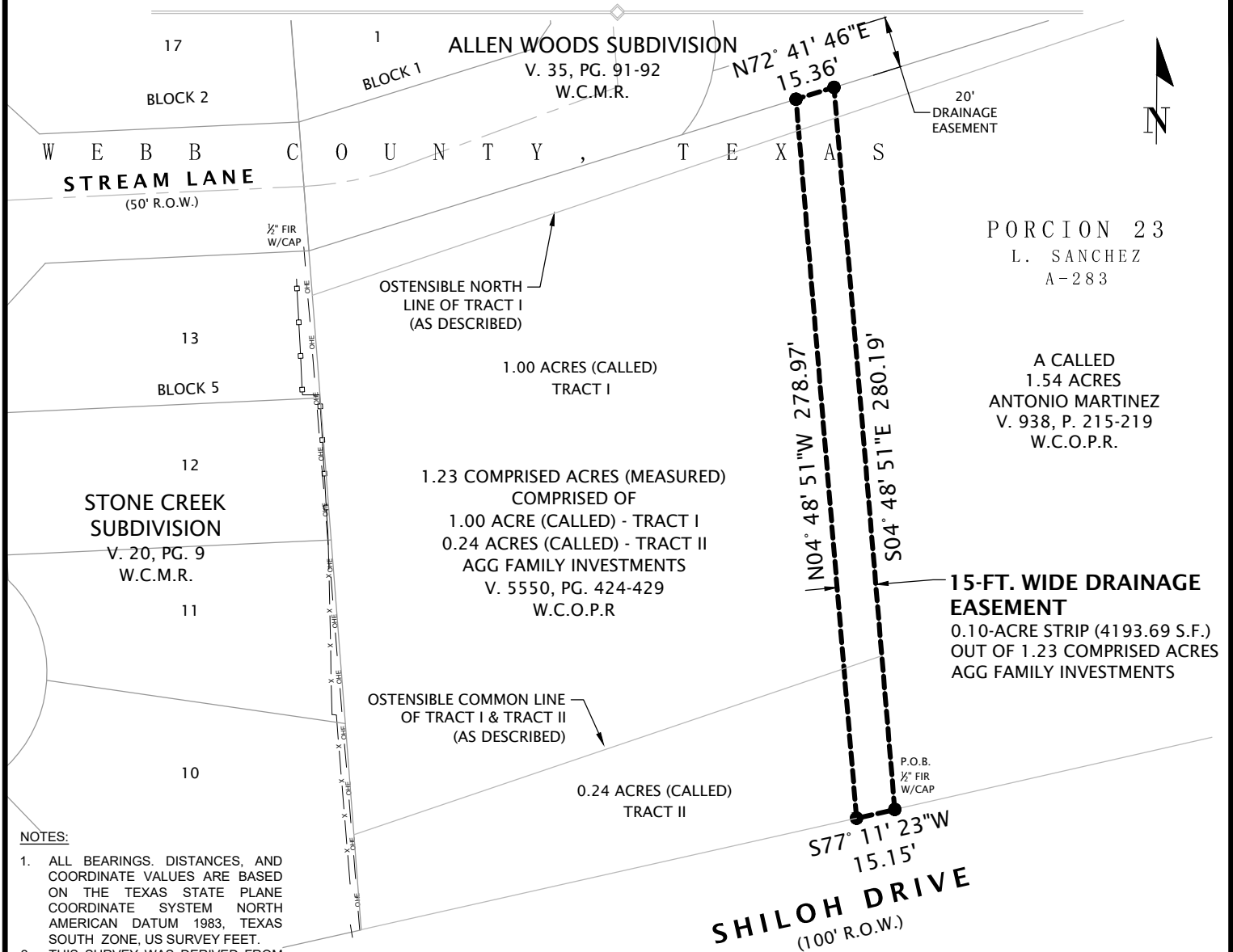

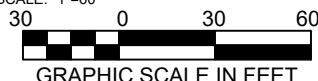

ON THE EAST LINE OF STONE CREEK SUBDIVISION, RECORDED IN VOLUME 20, PAGE 9, WEBB COUNTY MAP RECORDS, BEING THE SOUTH CORNER OF ALLEN WOODS SUBDIVISION, RECORDED IN VOLUME 35, PAGES 91-92, WEBB COUNTY MAP RECORDS,; THENCE, S 04° 24' 01" W, AT 17.21 FEET **THE POINT OF BEGINNING** AND THE NORTHWEST CORNER HEREOF;

THENCE S 77° 11' 23" W AT 15.15 FEET WITH THE SOUTH LINE OF SAID TRACT II AND 1.23 ACRES, AND THE NORTH RIGHT-OF-WAY LINE OF SAID SHILOH DRIVE, THE SOUTHWEST CORNER HEREOF;

THENCE N 04° 48' 51" W OVER AND ACROSS SAID 1.23 ACRES, BEING TRACT I AND TRACT II, AT 278.97 FEET TO THE OSTENSIBLE SOUTH LINE OF STREAM LANE, A 50-FT. WIDE RIGHT-OF-WAY, BEING THE SOUTH LINE OF ALLEN WOODS SUBDIVISION, RECORDED IN VOLUME 35, PAGES 91-92, WEBB COUNTY MAP RECORDS, FOR THE NORTHWEST CORNER HEREOF;

THENCE N 72° 41' 46" E CONTINUING WITH THE SOUTH RIGHT-OF-WAY OF SAID STREAM LANE, THE SOUTH LINE OF SAID ALLEN WOODS SUBDIVISION, AT 15.36 FEET THE NORTHEAST CORNER HEREOF;

THENCE S 04° 48' 51" E ALONG THE COMMON LINE OF SAID 1.23 ACRES AND CALLED 1.54 ACRES, AT 220.56 FEET PASS THE OSTENSIBLE COMMON LINE OF SAID TRACT I & TRACT II, CONTINUING A TOTAL OF 280.19 FEET **THE POINT OF BEGINNING** AND CONTAINING 0.10 ACRES (4,93.69 S.F.), MORE OR LESS.
