

**TEXAS HEALTH AND HUMAN SERVICES COMMISSION

AMENDMENT NO. 1**

The **HEALTH AND HUMAN SERVICES COMMISSION** (“**HHSC**” or “**System Agency**”) and **CITY OF LAREDO** (“**Grantee**”), who are collectively referred to herein as the “**Parties**,” to that certain Child Health and Dental Fee for Service agreement that was effective September 1, 2024, and denominated as HHSC Contract No. HHS001392700008 (the “**Grant Agreement**” or “**Contract**”), now desire to amend the Grant Agreement.

**WHEREAS**, HHSC desires to update funding for State Fiscal Year 2025 and revise the projected number of eligible clients to be served; and

**WHEREAS**, the Parties desire to add certain terms for compliance with applicable law and HHSC policy.

**NOW, THEREFORE**, the Parties amend and modify the Grant Agreement as follows:

1. **SECTION V, SUBSECTION A, TOTAL BUDGET**, of the Grant Agreement is amended as follows:
  - a. The Grant Agreement is amended to decrease funding in the amount of \$27,268.00 for State Fiscal Year 2025. The new total not-to exceed amount is \$27,268.00.
  - b. The Grant Agreement is amended to decrease funding for Child Health in the amount of \$27,268.00 for State Fiscal Year 2025.
  - c. Table 1 – Child Health is deleted and replaced by the revised Table 1. All expenditures for Child Health under this Grant Agreement will be in accordance with the following cost category:

5. Except as amended and modified by this Amendment No. 1, all terms and conditions of the Grant Agreement shall remain in full force and effect.
6. Any further revisions to the Grant Agreement shall be by written agreement of the Parties.
7. Each Party represents and warrants that the person executing this Amendment No. 1 on its behalf has full power and authority to enter into this Amendment No. 1.
