<b>PREVIOUS COUNCIL ACTION:</b> Year seven (7) contract for \$171,991.92 was approved by city council on 12/02/24.												
<b>BACKGROUND:</b> City Council at its meeting of November 20, 2017, approved an amendment to the Services Agreement with Superion Public Sector for FY2018. This amendment to the Services Agreement with Superion Public Section for OPENGOV Open Data software services delivered and deployed the OPENGOV Open Data Platform and Performance Dashboards. Purchase of OpenGov through Superion is no longer available, therefore purchase will be through Vertosoft TX-DIR: DIR-CPO-5327.
