

CITY OF LAREDO ORDINANCE NO. 2026-O-51

AN ORDINANCE OF THE CITY OF LAREDO, TEXAS, AMENDING CHAPTER 23 - PARKS AND RECREATION DEPARTMENT, OF THE CODE OF ORDINANCES OF THE CITY OF LAREDO TO AMEND CHAPTER 23-6, SECTION 2, FEE SCHEDULE FOR THE BUENA VISTA SPORTS COMPLEX TO ALLOW RETAIL VENDOR SPACE RENTAL FEES AND ALSO AMEND THE DEFINITION OF HOURS OF USAGE FROM ALL DAY TO MEAN THE PERIOD OF TIME FROM 8AM TO 10PM; PROVIDING FOR PUBLICATION AND AN EFFECTIVE DATE; AND PROVIDING FOR SEVERABILITY.

WHEREAS, the Buena Vista Sports Complex was constructed to provide organized sports venues, promote tourism, and enhance the quality of life; and

WHEREAS, the City of Laredo Parks and Recreation Department shall oversee the operation, maintenance, programming, and rental of the complex; and

WHEREAS, Buena Vista Sports Complex has not yet commenced operations, and no fees have been imposed or collected; and

WHEREAS, the City of Laredo finds that revising the fee schedule and amending the definition of hours of usage prior to the facility's opening will enhance accessibility while ensuring sustainable operation of the facility.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAREDO:

SECTION 2.

Fee Schedule for the Buena Vista Sports Complex is amended to include retail vendor space rental fees.
