AUTHORIZING THE CITY MANAGER TO SUBMIT A GRANT APPLICATION TO THE FEDERAL TRANSIT ADMINISTRATION COMPETITIVE FY2023 SECTION 5339(b) BUSES AND BUS FACILITIES GRANT PROGRAM IN THE AMOUNT OF \$20,000,000.00 WITH A LOCAL MATCH OF 20% TO 50% OF TH TOTAL GRANT AMOUNT OF \$25,000,000.00. MATCH WILL BE FROM CO BOND AND LAND AS IN-KIND FOR \$2,372,229.00 FOR THE CONSTRUCTION AND COMPLETION OF PHASE I AND PHASE II OF THE NEW EL METRO TRANSIT ADMINISTRATION, OPERATIONS, AND FLEET MAINTENANCE FACILITY.

WHEREAS, the City of Laredo, Texas, is requesting discretionary federal funding for the construction and completion of Phase I and Phase II for the El Metro Transit Administration, Operations, and Fleet Maintenance Facility, and

WHEREAS, the City of Laredo, Texas, will use the local match requirement of a bond and land as In-Kind for \$2,372,229.00.

- **Section 1.** the City Manager and staff are authorized to submit a competitive grant application to the Federal Transit Administration FY2023 Section 5339 (b) Buses and Bus Facilities Competitive Grant Program in the amount of \$25,000,000.00 and
- **Section 2.** the City Manager and staff are authorized to execute all necessary documents relating the said Grant; and
- **Section 3.** the bond and land as In-Kind for \$2,372,229.00 will be used for local match.
